- There is no financial commitment on the part of any parties to take up any programs mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and design) of the other Party.

VALIDITY

While both look forward to a long-term relationship turning into a win-win approach for both parties, the parties shall enter into the AGREEMENT **for an initial term of two (2) years** and thereafter review and renew the AGREEMENT on mutually agreed terms. Strategic and Governance board shall identify the necessary terms of reference for such periodic review.

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both Parties have to discharge their obligations. However, no such early termination of this AGREEMENT, whether mutual or unilateral, shall affect the obligations of the participants under any Research AGREEMENT. Neither party is entitled to any compensation in the event of termination of this AGREEMENT.

RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that First Party and Second Party are acting under this MOU as independent entities, and the relationship established under this MOU shall not be constructed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have any authority under the terms of this MOU to make agreement of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
