



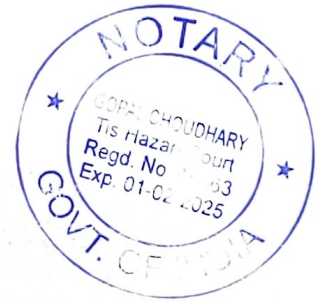

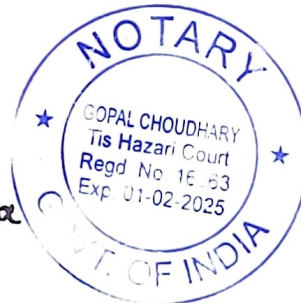

Memorandum of Understanding

This Memorandum of Understanding (MoU) is entered into this day Monday of August, 9th, 2021 by and between:

Xavier's Resource Center for the Visually Challenged (XRCVC, which is a department of St. Xavier's College, autonomous part of The Bombay St. Xavier's College Society. Having its Registered Office at St. Xavier's College, 5, Mahapalika Marg, Mumbai – 400 001, (hereinafter called the "XRCVC"), which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include, its successors and permitted assigns) represented by its Authorized Signatory- Dr. Sam Taraporevala – Executive Director, XRCVC.

AND

Kirori Mal College University of Delhi, having its registered office at University of Delhi, University Enclave, Delhi, 110007 (hereinafter called the "KMC", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include, its successors and permitted assigns) represented by its Authorized Signatory- Prof. Vibha Singh Chauhan– Principal, Kirori Mal College.

XRCVC and KMC are hereinafter individually referred to as "Party" and collectively as "Parties".

The XRCVC has developed expertise in accessibility and promoting social inclusion for persons with disabilities. It has implemented a model of promoting such inclusion within educational spaces. It has developed a workable consultancy model (SHAMIL) (See Annexure 'A') which it can offer to interested educational institution.

The KMC is keen to effectively implement a systematic social and educational inclusion initiatives for persons with disabilities on its campus.

Given the fact that both parties share a common goal and purpose in helping persons with disabilities experience effective educational inclusion they would like to work together as part of a collaborative project to help build an effective model of educational inclusion for persons with disabilities at KMC. Towards this end the parties agree to the following:

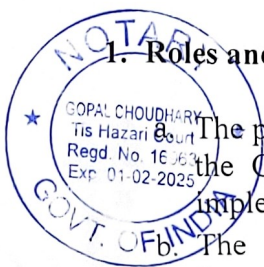
1. Roles and Responsibilities

The project will be housed at KMC and the Principal of KMC shall authorise the Centre for Disability Research and Training, KMC to roll out and implement the project on behalf of the college.

The Principal of KMC, in consultation with the Centre for Disability Research and Training, KMC shall, from among the faculty members of the college associated with the centre, appoint one project coordinator and one project co-coordinator to oversee and supervise the implementation of the project.

- c. In order to help the said project the XRCVC would be appointed as honorary consultant by KMC.
- d. The XRCVC will provide its expertise in the area of educational inclusion by offering guidance, training, systems and processes in the area of accessibility and inclusion for persons with disabilities to KMC.
- e. For its part KMC will be open to implement the planned role out strategy for educational inclusion for persons with disabilities on its campus through the SHAMIL model. For this it will be prepared to allocate organisational resources both material and human to ensure the effective implementation of the project. It will also be prepared to align its policies in tune with the various legal provisions in force which have a bearing on persons with disabilities provided these changes are not in contravention to the rules and regulations of Delhi University.

2. Duration

This MOU will be in force for the period of Three years from the date of signing. This agreement can be terminated by either party upon 1 month's advance notice to the other party.

3. Financial

The XRCVC is offering its services on a pro bono basis. Any mutually agreed and sanctioned incidental expenses such as travel etc which may be required for the project will be borne by KMC. KMC will in addition be responsible for finding resources to meet the cost of the project which would include setting up and running support service for persons with disabilities and any other expenses that may come up from time to time to ensure effective role out of SHAMIL and the inclusion of students with disabilities.

4. Non-Exclusive

It is agreed and clarified that this MoU is on a non-exclusive basis and the parties are at liberty to sign similar MoU's with others.

Publicity and Public Information

KMC will give due credit to the XRCVC's role in any media/publicity or press for work taken under the ambit of this MoU.

5. Representation and Warranty:

All parties represent and warrant that they are under no contractual or other restrictions or obligations which are inconsistent with the execution of this agreement or which will interfere with the performance of the engagement.

The parties are entering into this agreement with the full intention of ensuring educational inclusion for persons with disabilities. Either or both parties cannot be held liable for any shortcoming / problem that may arise during the process.
