Request for Proposal:-

1. It is the vision of the Kirori Mal College to have an inclusive society in which equal opportunities and access is provided for the growth and development of Persons with Disabilities (PwDs) to lead productive, safe and dignified lives. In this direction, the Principal, Kirori Mal College, University of Delhi under the guidelines of Department of Empowerment of Persons with Disabilities (DEPWD), Ministry of Social Justice & Empowerment which has also launched the “**Accessible India Campaign (Sugamya Bharat Abhiyan)**” as a nation-wide flagship campaign for achieving universal accessibility for PwDs invites the request for proposal for rendering the services for providing accessibility audit report for the existing buildings of the Kirori Mal college.
2. One of the targets under the objective of enhancing the proportion of accessible buildings under nation-wide Accessible India Campaign is to conduct accessibility audit of the buildings and converting them into fully accessible buildings. Access audits are an important means of ensuring the accessibility.
3. All the buildings of the college are proposed to be audited for accessibility in the Kirori Mal College as per the attached term and conditions.

The terms and conditions of allocations are given as under:-

- (i) The bidders shall submit bid for all the buildings and open area in the college.
- (ii) A partial bid submitted for some of the buildings/infrastructure will not be considered and will be summarily rejected without any further correspondence.
- (iii) The bid must be made keeping in mind that are being considered as single units. For example, the college may include multiple buildings within the premises. In such cases, the bid is to be made for the entire complex as one unit.
- (iv) The bid is to be made for the entire building/infrastructure as a single unit irrespective of floors/blocks it may have and not as a separate floor/block.
- (v) After submission of cost estimation, if the organization is selected, it will not be allowed to withdraw from the access audit by stating some reasons. In such case, the organization will be black-listed.
- (vii) The access audit has to be completed and report is to be submitted within 30 days from the date of work order. The first 10 days will be for liaisoning and coordination concerned department. The report shall have to be submitted within balance 20 days.
- (viii) The report shall have to be given separately in relation of each building/infrastructure.
- (ix) The payment shall be released within 30 days of completion & submission of access audit report of each building/infrastructure separately and its acceptance by the competent authority.
- (x) 20% of the bid amount will be deducted for submission of access audit report beyond 7 days later than the deadline and 40% of the bid amount will be deducted, if report is submitted more

than 14 days late without any valid reason to be assessed by the Office of The Principal, Kirori Mal College, University of Delhi. The Access Auditor would be blacklisted if the access audit report is not submitted within 30 days.

- (xi) Office of the Principal, Kirori Mal College, University of Delhi reserves the right to reject any bid without assigning any reasons and no further correspondence shall be entertained.

Special Terms and Conditions: The entire work shall be completed within a maximum period of 30 days from the date of work order.

Scope of work

Conducting access audit of the identified college buildings at Kirori Mal College, University of Delhi. Providing a comprehensive report consisting sample drawings and 3D renderings for recommendations.

Eligibility criteria:

- Empanelled organizations for conducting access audit for various Government Departments/ Govt. Educational Institutions.
- Organization to have an in-house team of architects and civil engineers along with cross-disability specialists and persons with disabilities. Their resumes should be submitted along with the bid.

Evaluation of Financial bid

- a. The financial bids shall indicate the cost estimate bid of access audit for Kirori Mal College, University of Delhi.
- b. Conditional Bid shall be liable to be rejected.
- c. If there is discrepancy between the price/information quoted in words and figures, the price/information in words would be treated as final.

Payments

The payment shall be released within 30 days of completion & submission of access audit report of each building/infrastructure separately and its acceptance by the competent authority.

Submission of Bid

The bidder shall bear all costs associated with preparation and submission of its bid. O/o of The Principal, Kirori Mal College, University of Delhi will in no case be responsible or liable for those costs, regardless of the outcome of the tendering process.

Sealing and marking of Bids

- i. The bids must be submitted as under:

The envelope shall be sealed and super scribed 'Bid- The Principal, Kirori Mal College, University of Delhi tender for "Access Audit of buildings at Kirori Mal College, University of Delhi'

- ii. The envelopes shall indicate the names and addresses of the bidder to enable the bid to be returned unopened in case it is declared late
- iii. Telex, cable and facsimile bids will be rejected

Deadline for submission of Bids

- i. Bids must be received by this office at the address given not later than the time and date specified. In the event of the specified date for the submission of bids being declared a holiday for o/o of The Principal, Kirori Mal College, University of Delhi, the bids will be received up to the appointed time on the next working day.
- ii. The Principal, Kirori Mal College, University of Delhi may, at his discretion extend this deadline for submission of bids by amending the bid documents, in which case all rights and obligations of The Principal, Kirori Mal College, University of Delhi and bidder previously subject to the deadline will thereafter be subject to the deadline as extended.

Late Bids

Any bid received by this office after the deadline for submission of bids prescribed in the bid will not be considered and/or returned unopened to the bidder. Kirori Mal College, University of Delhi will not be responsible for any postal delay or non-receipt/non-delivery of the bid. No further correspondence will be entertained on the subject.

Opening of Bids

The bids will be opened in the first instance in the presence of bidder's representatives who chose to attend, at the time, on the date and at the place specified. The bidders' representatives present there, shall sign a register evidencing their attendance. In the event of the specified date of the bid opening being declared a holiday for Kirori Mal College, University of Delhi, the bids shall be opened at the appointed time and location on the next working day.

Rejection of Proposals and Split Awards

The Principal, Kirori Mal College, University of Delhi reserves the right to reject any and all proposals if they are, inter alia:

- received after the deadline stipulated in the Request for Proposal;
- not properly marked or addressed as required in the Request for Proposal;
- delivered to other office locations than the one required in the Request for Proposal;
- Transmitted by facsimile.

Withdrawals and Modification of Proposals

Proposals may be modified or withdrawn in writing, prior to the proposal closing time specified therein. Proposals may not be modified or withdrawn after that time.
