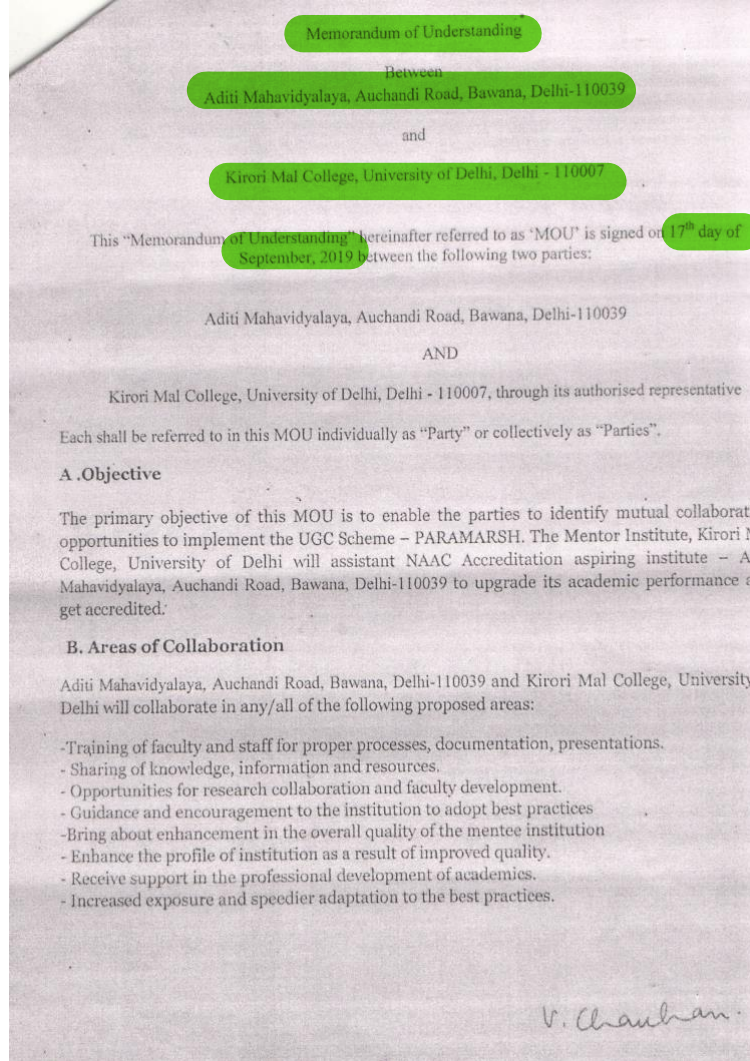

A. General Provisions

1. The parties agree that they shall use their best endeavours to execute the provisions of this MOU. As such, this MOU is non-binding in nature and can't be legally pursued.

A detailed implementation plan may be drawn up annually by both the parties under this Agreement.
3. This MOU shall become effective on and from the date of execution hereof and shall continue to be effective for two years. After this period, it may be extended by the parties based on mutual agreement in writing until it is rescinded. This MOU may be terminated by either party by issuing a one month prior written notice at any time during the validity of this MOU to the other party.
4. The MOU shall be revisited as and when needed by both the parties with a view to the scope of the same.
5. The Aditi Mahavidyalaya, Auchandi Road, Bawana, Delhi-110039 will not have financial obligation.
