Subject: Conduct of Internal Assessment (IA), Practical, Viva-Voce, Projects, Oral (Moot courts) Apprenticeship, Internship, Field Work etc. for 2019-20.

Sir/Madam,

The following procedure shall be followed for conduct of Internal Assessment, Practical, Viva-Voce, Projects, Oral (Moot courts), Apprenticeship, Internship, Field Work which are required for completion before the conduct of End Term Theory Examinations.

- Internal Assessment:Instead of the three existing components of Internal Assessment, viz., Class Tests, Tutorial Test and Attendance, only one component i.e. internal assignments will be carried out for the current semester. Internal assessment of the students should also be carried out using IT tools. Teacher should give the assignment to the students in prescribed format via e-mail. The student should submit the solved assignment to the teacher via e-mail in a defined time. The top of the Assignment Sheet must have Program name, Semester, Title of Paper and Name of the Student. After evaluation, respective teacher will submit the result of the same to the o/o the principal of the college and to the o/o the Head of the Department in the case of PostGraduation. Those who have already completed the process of internal assessment in the continuous form or as per existing rule in this regard are required to submit the same to the o/o the principal of the respective college. Attendance component in IAshall be considered full for the lockdown period and benefit should be granted to all students while calculating IA for each paper as per the distribution of marks.
- Examination of Practical Courses: The evaluation of Practical Examination, wherever applicable, will be in the 100% continuous evaluation mode. For Laboratory paper, teacher should give the assignment based on Experiments already performed through email to the students. The student should submit the solved assignment to the teacher via email in a stipulated time period. The name of Program, Semester, title of practical paper and name of the student should be mentioned at the top of the answer sheet by the student before submission.
- Practical and Viva voce, Oral (Moot courts) Examinations: For final and Intermediate
 semester/Term/Year students of all professional and technical programs, all such practical
 and viva voce as part of the requirements of the completion of degrees for final semester
 /Term/Year students should be conducted through Skype or other meeting apps.

- Conduct of Internship/Apprenticeship for all Semester/Term/Year: Following
 measures in the view of COVID-19 shall be undertaken by all concerned as required for
 completion of degrees in professional/ technical course etc. wherever applicable:
 - 1) Students shall be allowed to take up online internship/ activities including activities that can be carried out digitally or otherwise from home.
 - 2) They can be engaged as interns in ongoing projects.
 - 3) The date for start can be delayed.
 - 4) The period of internship can be reduced clubbing with assignments etc.
- Evaluation Dissertations of UG/PG programs is to be conducted by written assignments based on the work carried out by the students before the lockdown (i.e. March 20, 2020).
 Such evaluations are to be performed in the form of written assignments by the respective teacher through e-mails within a defined time period.
- In the present scenario, appropriate measure has to be adopted to facilitate the UG/PG students pursuing Projects/Dissertation, accordingly review-based/secondary data based projects or software driven projects shall be accepted by the college/ department instead of laboratory based experiments or field/ survey based assignments to these students.

All are requested to adhere to the above suggested guidelines to complete activities in time. Further, if the above activities have already been completed by your Faculty/Department/ College/Teaching Centre before closure of the University, you are requested to immediately send the requisite data to the Examination Branch as per existing practice.

Internal Assessment Instructions 200520.docx

Dear Colleagues

The Dean (Examinations) in his letter dated 13.05.2020 has instructed us to modify the manner in which Internal Assessment has to be conducted and submitted this semester. Following that we are elaborating the method of carrying out internal assessment for the current semester:

- Internal Assessment should be submitted in two different components Assignment (20 marks) and Attendance (5 marks).
- 2) When you go to the internal assessment portal, log on and select courses and students as usual, you will find the Test column disabled. Only the assignment column will be active and of 20 maximum marks. Attendance data has to be filled as in the past but the attendance calculation will be different as indicated below.
- 3) If a teacher has already taken both the assignment (10 marks) and the test (10 marks), their marks should be added up and submitted compositely as Assignments (20 marks). If some students have missed the test, please take another assignment or suitably increase their assignment marks out of 20 since a re-test won't be possible.
- 4) If a teacher has taken an assignment already on 10 marks submit that by doubling the marks obtained (i.e. out of 20 marks)
- 5) If a teacher has taken only a test and not an assignment, the test can also qualify for submission as assignment for 20 marks. However, please make sure that if some students have missed the test they should be given chance to submit an assignment instead.
- 6) If a teacher has not taken any assessment (assignment or test) till now, please give an assignment (20 marks) to the students, which can be submitted through e-mail to the teacher by a specific date. Given that some students are at home without proper study material or they are in remote areas where access to internet may be uncertain, please give adequate choice and time. The students can either type the assignment in word file and mail it as an attachment or they can write in on paper and e-mail the scanned copy. Please instruct them clearly to write their name, roll number, semester, class and course-name on the first sheet of the assignment as well as their name in the filename of the word / pdf / jpg file they submit.
- 7) The attendance part will have two components. For the total lectures delivered add up (i) the actual classes held till the midterm break (LD1) and (ii) the hypothetical classes which would have been held in the period between 16 March to 15 May (LD2). For the lectures attended add up (i) the actual lecture attended by the student till the midterm break (LA1) and (ii) 100% of the hypothetical classes which would have been held in the period between 16 March to 15 May (LD2, that is the same as component (ii) of lectures delivered.) In other words, the total lecture delivered should be LD1+LD2 and total lecture attended should be LA1 + LD2. It is further suggested that because the period between March 16 and May 15, 2020 has 9 weeks and there are 4 schedules holidays in that period, we can calculate LD2 as (9x5 4) = 41 classes for courses with 5 lectures a week and as (9x4 4) = 32 classes for courses with 4 lectures a week. This could be followed by all teachers, unless they were on leave in this period.

So, <u>for example</u>, if for a 5 lecture per week course the actual lectures delivered before the break was 30 and a student had attended 20 of them, then Total LD = 30+41=71 and total lectures attended will be 20+41=61.
