### B. Areas of Collaboration

- Organising Trainer's Training Progragmme for the trainers in the area of entrepreneurship skills and education
- ii. Developing course curriculum on entrepreneurship
- iii. Entrepreneurship Orientation of the trainees through E-learning modules
- iv. Identifying entrepreneurial opportunities and programs
- v. Workshops and incubation support through industries as a part of their CSR.
- vi. Preparation and exchange of Course Design and Exchange of faculty and software
- Promoting entrepreneurial activities amongst the stakeholders of skill ecosystem.
- viii. Promoting self employment opportunities for Trainees of the college.
- ix. Any other activity that can be taken up to promote entrepreneurship development

None of these provisions of this MoU shall be deemed to constitute a partnership between the parties here to and no party shall have any authority to bind or shall be deemed to be agent to the other in any manner. A detailed implementation plan may be drawn up annually by both the parties under this Agreement.
- This MOU shall become effective on and from the date of execution hereof and shall continue to be effective for three years. After this period, it may be extended by the parties based on mutual agreement in writing until it is rescinded. This MOU may be terminated by either party by issuing a one month prior written notice at any time during the validity of this MoU to the other party.
- The MOU shall be revisited as and when needed by both the parties with a view to the scope of the same.
- The Kirori Mal College will make payment to the NIESBUD for the consultancy, mentorship, and lectures as per the UGC guidelines and schedule decided mutually.
- The NIESBUD will help Kirori Mal College in designing course curriculum and will provide resource persons and consultancy for the entrepreneurship and start –up course.
