- The parties agree that they shall use their best endeavours to execute the provisions of this MOU. As such, this MoU is non-binding in nature and can't be legally pursued.
- None of these provisions of this MoU shall be deemed to constitute a partnership between the parties here to and no party shall have any authority to bind or shall be deemed to be agent to the other in any manner. A detailed implementation plan may be drawn up annually by both the parties under this Agreement.
- 3. This MOU shall become effective on and from the date of execution hereof and shall continue to be effective for three years. After this period, it may be extended by the parties based on mutual agreement in writing until it is rescinded. This MOU may be terminated by either party by issuing a one month prior written notice at any time during the validity of this MoU to the other party.
- The MOU shall be revisited as and when needed by both the parties with a view to the scope of the same.
- 5. The Kirori Mal College will make payment to the DISET for the consultancy, mentorship, and lectures as per the UGC guidelines and schedule decided mutually.
