



Memorandum of Understanding

This “Memorandum of Understanding” hereinafter referred to as ‘MOU’ is signed on this 24th day of March, 2021 between the following two parties:

Mizoram University, Aizawl, Mizoram
AND

Kirori Mal College, University of Delhi, Delhi - 110007,

through its authorised representative, Each shall be referred to in this MOU individually as “Party” or collectively as “Parties”.

A. Objective

The primary objective of this MOU is to enable the parties to identify mutual collaboration opportunities bringing together the strengths of both Mizoram University and Kirori Mal College, University of Delhi toward Faculty Development and Short term Training Programmes of Faculty Development Centre (FDC) under Pandit Madan Mohan Malviya National Mission on Teachers and Teaching (PMMMNTT), Mizoram University, Aizawl, Mizoram in Offline and Online Mode

B. Areas of Collaboration

The Kirori Mal College, University of Delhi will collaborate with Mizoram University any/all of the following proposed areas:

- i. Faculty Development Programmes.
- ii. Short Term Training Programmes
- iii. Orientation Course/ Refresher Courses
- iv. Preparation and exchange of Course Design and Exchange of faculty.
- v. Any other activity that can be taken up to promote capacity building or faculty development.

A. General Provisions

1. The parties agree that they shall use their best endeavours to execute the provisions of this MoU. As such, this MoU is non-binding in nature and can't be legally pursued.
2. None of these provisions of this MoU shall be deemed to constitute a partnership between the parties here to and no party shall have any authority to bind or shall be deemed to be agent to the other in any manner. A detailed implementation plan may be drawn up annually by both the parties under this Agreement.
3. This MoU shall become effective on and from the date of execution hereof and shall continue to be effective for three years. After this period, it may be extended by the parties based on mutual agreement in writing until it is rescinded. This MoU may be terminated by either party by issuing a one month prior written notice at any time during the validity of this MoU to the other party.
4. The MoU shall be revisited as and when needed by both the parties with a view to the scope of the same.
